This application form MUST BE accompanied by the correct relevant fee if D/D is made a copy of the transaction receipt is required.(Please refer to current fee structure) and a color photo of each side of the pony AND...

1. **Foal Recording** - if you used an outside stallion, a Service Certificate is required.
2. **Adult Registration** - if the pony was Foal Recorded with the Society, the Foal Recording Certificate must accompany the application with a current photo of each side of the pony.
3. **Measurement** - if you are Adult Registering or Appendix Recording, Ponies must have an official measurement.
4. **Appendix Recording** - You must supply the Foal Record or Adult Registration Certificate with the application.
5. **Stallion Registration** - You must supply the Society's Veterinary Certificate of Soundness.
6. **Microchipping** - If you are using Microchipping as your only form of identification you must supply you pony's microchip label in the space provided

1. This form will be used to make out the Registration Certificate. Please make sure that we can read what you have written. We do not correct spelling of pony's names.
2. A Stud prefix must be registered with the Society and be included in the pony's name. The maximum length for the prefix is 17 letters (including spaces) and for the pony's name (including prefix) is 30 letters (including spaces, punctuation, etc).
3. The owner MUST be a financial member of the Australian Miniature Pony Society Inc.
4. Ponies must not exhibit any condition shown in the Rules & Regulations of the Society to be grounds for disqualification.
5. All ponies are to be measured by an Official Measurer of the Society on application for Adult registration or Appendix Recording and again at 4 years of age (and before 5 years). Any pony measuring 85.5cm or more at 4 or (Appendix Recorded measuring 89.5cm or more at age 4) is to be remeasured at age 6 years (and before 7 years). For 4 year heights (and 6 year height, where relevant) the Adult Registration / Appendix Recording Certificate and Height Certificate from Official Measurer is to be forwarded to the Society's Secretary for endorsement of height. PLEASE NOTE that height certificates are valid for 3 months from the date of issue.
6. If and only if an Official Measurer is not available, application may be made to the Society's Secretary in writing for a vet or other approved person to measure. The application must include the names and ages of the ponies to be measured. If the Secretary is satisfied that an Official Measurer is not available, approval can be given.  
PLEASE NOTE that such an approval is not a blanket approval to use a vet, etc. and approval must be sought for each pony as the need arises.
7. An Appendix Pony is NOT AN AUSTRALIAN MINIATURE PONY and is NOT ELIGIBLE to be shown as an Australian Miniature Pony.
8. If this pony is registered with any another Registry, a copy of the registration papers must accompany this application.
9. Foal Recorded Ponies must be Adult registered at 2 if they are going to be Shown, Sold or Bred with
10. Ponies are eligible to be Adult registered at 2 years (actual) and must be before 4 years (actual).
11. Foal Recording will be no longer valid if the pony is over 4 years old or has been bred from when application is made for Adult Registration.
